Chubb Equipment Breakdown Risk Engineers (EBREs) are responsible for conducting all routine jurisdictional inspections for the New Jersey Schools Insurance Group in accordance with the provisions of N.J.A.C 12.90. Chubb Equipment Breakdown Risk Engineers are commissioned to perform boiler and pressure vessel inspections as required by the State of New Jersey. The certificate handling fees for locations covered under your policy will be directly billed to the respective school district.

### Jurisdictional Inspection Program

Chubb Equipment Breakdown Risk Engineers (EBREs) conduct all jurisdictional inspections of pressure retaining objects in compliance with the State of New Jersey’s Bureau of Boiler and Pressure Vessel Compliance. Utilization of Jurisdictional Online (JO) allows Chubb users instant access to the State of New Jersey Jurisdictional Database to effectively manage all New Jersey Schools Insurance Group locations. Chubb’s participation in the JO platform allows Chubb EBREs to manage any overdue locations, ensures accurate contact information, minimizes visitations by state inspectors, and enables Chubb the ability to efficiently manage the portfolio of locations. Chubb’s access to JO also provides a snapshot of inspection history, open/closed violations, and active/inactive objects. Chubb EBREs are required to submit all inspections within 7 days ensuring all certificates are delivered to each of the New Jersey school districts within a timely manner.
