### April Showers Bring... Mold How to Prevent Mold Growth in Your School Buildings

What do May flowers and mold have in common? They both love April rain showers! Make sure your buildings are being properly ventilated, and that someone is regularly monitoring for leaks and water damage.

Moisture problems in schools can be caused by a variety of conditions, including roof and plumbing leaks, condensation and excess humidity.

Suggestions for reducing mold growth in schools:

- Reduce indoor humidity
- Inspect the building for signs of mold, moisture, leaks or spills
- Respond promptly when you see signs of moisture and/or mold, or when leaks or spills occur
- Prevent moisture condensation
- Floor and carpet cleaning
