If your district is preparing for the **New Jersey Quality Single Accountability Continuum** (NJQSAC) inspection, NJSIG can provide a Pre-QSAC inspection to help identify potential issues in advance and ensure your schools are fully prepared for a successful review. Our vendor partner, **H&S Inspection Company**, will supply a qualified inspector to conduct the inspections and offer expert guidance to member districts.

Key Details:

- Each district is eligible for up to three inspections; we recommend selecting one elementary, middle, and high school to maximize the inspection service.
- By scheduling a Pre-QSAC inspection, districts can:
 - Identify and address potential compliance issues before the official NJQSAC review.
 - Gain peace of mind knowing facilities meet health, safety, and accountability standards.
 - Reduce the risk of costly violations or last-minute surprises.
 - Demonstrate a proactive commitment to student and staff safety.
- Pre-QSAC inspection reports will be provided to the member district for their records and future reference.
- Appointments are required, so we encourage member districts to schedule early to secure preferred dates.



Vector Solutions ADMIN Access Rights

Vector Solutions (formerly SafeSchools Training) is NJSIG's online training partner, offering more than 300 online courses at no cost to members. This includes, but it is not limited to, all courses that the New Jersey Department of Education requires.

For our members who are currently using Vector Solutions: If a member district already has an ADMIN, they can add additional ADMINS or USERS and remove users who no longer work in the district. Once an ADMIN adds you to the site, they can also grant you administrative permissions.

ADMINs have the ability to:

- Manually add, edit, deactivate, and reactivate users
- View users' course history and certificates
- Manually provide credit for assignments
- Mark users as Exempt or Completed Offline

All these permissions and functions are available on Vector Solutions Data Management.
