### Winter Weather Readiness for New Jersey Schools

With an impending arctic blast and winter snowstorm expected to impact New Jersey this weekend, school districts face heightened winter-related risks, including slip-and-fall incidents, property damage, transportation disruptions, and potential power outages. Proactive winter preparedness is essential to minimizing claims, protecting facilities, and maintaining safe learning environments for students and staff. Planning ahead allows districts to respond more effectively to extreme cold, snow accumulation, and other severe winter weather conditions.

#### Risk-Focused Winter Preparedness Tips:

- **Ensure heating systems remain on and set to appropriate minimum temperatures during cold weather, including overnight, weekends, and school closures, to help prevent frozen pipes and related property damage.**
- Review emergency operations and continuity plans, including procedures for delayed openings, closures, and early dismissals.
- Inspect and maintain heating systems, roofs, gutters, and pipes to prevent freeze-related damage and water losses.
- Coordinate snow and ice removal to reduce slip-and-fall hazards on walkways, parking areas, and entrances.
- Ensure clear communication systems are in place to share weather-related updates with staff, families, and transportation partners.
- Monitor weather alerts and forecasts to support timely decision-making and safe operations.

Taking these steps can help reduce winter-related incidents, limit property and liability exposures, and support a safer school environment throughout the season.
