**WHEREAS**, the New Jersey Schools Insurance Group (“NJSIG”) is authorized by N.J.S.A. 18A:18B-1, et seq. to provide insurance coverage for its members;

**WHEREAS**, NJSIG requires professional services in the form of outside counsel to represent the interests of NJSIG’s members in insurance claims;

**WHEREAS**, NJSIG was recently notified that David Porter, Esq., an attorney at a law firm currently approved to represent NJSIG members in general and complex workers’ compensation litigation matters, has left their existing employment to join the following law firm: Porter Gidaro & Bryant LLC;

**WHEREAS**, the matters in which David Porter, Esq. represents NJSIG members are in varying stages of litigation, and David Porter, Esq. is currently the attorney most familiar with the NJSIG member matters they were handling prior to their departure;

**WHEREAS**, if these matters remain at the current law firm, NJSIG would be required to expend resources for new attorneys to learn the matters so as to competently represent NJSIG members in those matters; and

**WHEREAS**, approving Porter Gidaro & Bryant LLC to represent NJSIG members in general and complex workers’ compensation matters would avoid those expenditures.

  - b. Complex Workers' Compensation Litigation:
    - i. Porter Gidaro & Bryant LLC
- 2) The Executive Director is hereby authorized to execute professional services agreements with the above-referenced service provider(s);
- 3) The Claims Manager is hereby authorized to retain firms designated as Outside Counsel that have executed a professional service agreement as to the above areas to represent NJSIG members in specific matters in accordance with NJSIG Policy 2212;
- 4) This designation is in accordance with the Public School Contracts Law, N.J.S.A. 18A:18A-1, et seq.;
