Resolution Authorizing the Execution of a
Contract Pursuant to the Public School Contracts Law

NJSIG No. 1024-04

WHEREAS, the New Jersey Schools Insurance Group (“NJSIG”) is authorized by N.J.S.A. 18A:18B-1, et seq. to provide insurance coverage for its members;

WHEREAS, NJSIG requires property field adjuster services, general liability and auto liability field adjuster services, and auto physical damage appraisal services to assist NJSIG’s Claims Department in conducting field investigations and procuring the documentation necessary for proper claims evaluation;

WHEREAS, NJSIG has engaged in a fair and open competitive contracting process, pursuant to which proposals were solicited; and,

WHEREAS, an evaluation committee was convened by NJSIG and has evaluated all proposals submitted.

NOW THEREFORE, BE IT RESOLVED that:

- 1) NJSIG awards contracts to the following vendors for the identified service(s) for a duration of three (3) years (or thirty-six (36) months), with provisions for two (2) optional one-year extensions:
 - a. SJJ Adjustment Company (property field adjuster services, general liability field adjuster services, and auto liability field adjuster services);

- b. New Jersey Claims Associates LLC (property field adjuster services, general liability field adjuster services, and auto liability field adjuster services);
 - c. Sedgwick Claims Management Services, Inc. (property field adjuster services, general liability field adjuster services, auto liability field adjuster services, and auto physical damage appraisal services);
 - d. Raphael & Associates (property field adjuster services, general liability field adjuster services, and auto liability field adjuster services); and
 - e. MSW Adjustment Group (property field adjuster services, general liability field adjuster services, and auto liability field adjuster services).
- 2) NJSIG awards the contracts to these vendors based on technical criteria, management criteria and cost criteria;
 - 3) The Executive Director is hereby authorized to execute contracts with the above-referenced vendors;
 - 4) This designation is in accordance with the Public School Contracts Law, N.J.S.A. 18A:18A-1, et seq.;


