WHEREAS, the New Jersey Schools Insurance Group (“NJSIG”) is authorized by N.J.S.A. 18A:18B-1, et seq. to provide insurance coverage for its members;

WHEREAS, NJSIG requires professional services in the form of outside counsel to represent the interests of NJSIG’s members in claims under NJSIG’s School Board Leader Liability/Errors and Omissions (SBLL/E&O) line of coverage;

WHEREAS, as outlined in NJSIG Board of Trustees Resolution No. 0624-10, NJSIG previously engaged in a fair and open competitive contracting process, pursuant to which proposals were solicited and evaluated, and thereafter designated a panel of law firms as Outside Counsel for School Board Leader Liability/Errors and Omissions litigation;

WHEREAS, NJSIG engaged in a fair and open competitive contracting process by issuing a supplemental request for proposals for Outside Counsel for School Board Leader Liability/Errors and Omissions Litigation, RFP # NJSIG-2024-007, pursuant to which NJSIG solicited proposals from additional law firms that are qualified to represent NJSIG members in SBLL/E&O matters and that wish to be added to NJSIG’s existing panel of law firms approved to represent NJSIG members in such matters;

- 5) A notice of this action shall be published once in the official newspaper designated by NJSIG, and is on file and available for public inspection at the office of NJSIG.


