# Confidentiality &Information Sharing (including with law enforcement and ICE)

When school officials over-share information and violate confidentiality requirements or under-share essential information the danger for real harm and potential legal liability skyrocket. In this session, participants will learn about the many state and federal laws that impact confidentiality and information sharing, and how to apply them in the school setting. The session will include a review of FERPA, HIPAA, 42 CFR Part 2, the Memorandum of Agreement between Education and Law Enforcement, legislation and guidance impacting reporting and record keeping.

## Artificial Intelligence, Deepfakes and the Law

Artificial Intelligence (AI) is rapidly transforming various sectors of our society, including education, in both positive and negative ways. AI is already being used to expand educational opportunities and enhance school district efficiency. This virtual workshop aims to explore the various applications of AI in the preK-12 setting, the legal duty of care that must be exercised as AI increasingly becomes part of the K-12 school experience, the latest guidance from the NJDOE and the impact of new state and federal laws addressing deepfakes.
